## Description

PROSAT *Sterile* Wipes utilize a meltblown polypropylene wipe which is exceptionally clean, being free from additives of any kind, and has a very low concentration of sodium. Increase solvent control and accountability and reduce VOC emissions with this sterile wipe. Compatible with ISO Class 5 cleanrooms.

Validated Sterile to a Sterility Assurance Level of 10<sup>-6</sup> in accordance with AAMI guidelines.
